## Financial Information 2022-2023(K4-Grade 8)

As of February 1, 2022

### Registration Fees

An initial Registration Fee must accompany the student's registration before processing begins. The enrollment process is comprehensive; therefore, it is non-refundable and non-transferable for any reason. Registration fees are paid when registration forms are submitted and cannot be prorated during the school year. **\*\*There is a \$50, non-refundable assessment fee for students in Grades 1-8. This fee is due the day of the assessment.**

### Curriculum/Supply Fees

Curriculum Fees (based upon book rentals and book and supply consumables) are due **August 1**. Students not paying the curriculum fees by August 1 will not be able to attend classes until this fee is paid. A \$25 late fee will be billed by August 5. Students enrolling after August 1 will be responsible to pay the registration and curriculum fees upon enrollment. *Please note that all curriculum fees are non-transferable and cannot be prorated regardless of enrollment date.*

### \*Art Fee: \$40

In order to alleviate the need for parents to purchase items throughout the school year, there will be a one-time \$40 art class fee included in the September invoice of students in K5-Grade 8.

### Tuition Fees

Tuition billing is available in annual, semi-annual and 10-pay payment plans. Tuition discounts are available for those paying the full annual tuition (5%) by July 15 or 2 semi-annual payments (3%) by July 15 and December 15 respectively. Those choosing the 10-pay plan will have the annual tuition divided into 10 equal payments with the first payment due July 15. The next payment will be due on the first calendar day of each month beginning September 1. Students attending one (1) day or more in a given month will be responsible for the entire month. Please note the school hours that are covered by the tuition payment.

- After School Care is not included in the tuition prices. See reverse side for After School Care prices.
- VPK credits are not reflected in the K4 prices. Please inquire at the School Office for current VPK scholarship credit information.
- Dollar-off scholarships are applied before any percent-off scholarships/discounts are applied. See reverse side.

## Financial Assistance

Hillsdale Christian Academy accepts the Voluntary Pre-Kindergarten (VPK) Program Scholarship and Step Up for Students Scholarship.

- **VPK Scholarship:** The VPK credit amount is set by the State of Florida each year. This established amount will be deducted in equal amounts from payments 1-10. To apply, parents must contact the Hillsborough County VPK office at [www.elchc.org](http://www.elchc.org).
- **Step Up for Students Scholarship:** This scholarship is available for eligible families with students entering Kindergarten through 12th grade. We accept the **Florida Tax Credit Scholarship**. To apply, parents must inquire about eligibility at [www.stepupforstudents.org](http://www.stepupforstudents.org).
- **AAA Scholarship:** This income-based scholarship is available for eligible families with students entering Kindergarten through 12th grade. Parents must check eligibility and apply at [www.aaascholarships.org](http://www.aaascholarships.org).

Hillsdale Christian Academy also offers a Tuition Assistance Scholarship through the generous gifts of God's people. Applicants can apply for this scholarship by submitting documentation received from the Administrator. Church attendance at Hillsdale Baptist Church is required to receive this scholarship.

## Financial Responsibilities

All accounts must be current in order for your student to attend class. Payments may be made online through our website, mailed to the Business Office or left in the drop box located inside the main school hallway. Receipts will be given at the front desk for all cash payments. All school records, report cards and file information will be held until the student account is current.

## Payment Source Requirement

As part of the billing process, it is required that a credit card or debit card number be submitted. This card will only be charged if the payment is not yet made 5 days following the tuition due date. All unpaid fees will be charged upon the day of Parent Orientation or enrollment if thereafter. A convenience fee of 2.75% will be added to all credit card and/or debit card transactions.

## Delinquent Accounts

The Business Office handles the collection of school payments. Payments are posted as paid on the day they are received. The Business Office will communicate with families by phone, email or letter regarding past due accounts requesting immediate payment. A student may not be allowed to continue at Hillsdale Christian Academy if the delinquent account has not been settled with the Business Office by the end of the month. No financial adjustments are made for student absences or family vacations. K4-8th Grade students attending one or more days of any month will be responsible for the entire month. School programs will be prohibited to students with delinquent accounts.

## Late Fees

All payment balances must be received in the Business Office by the 5th of each month, or a \$25 late fee will be billed to the account. If the 5th of the month falls on a weekend, the payment will be due on the closest business day to the 5th of the month.

## Returned Check Fee

A fee of \$30 will be billed to the account for any check that is not cashable for any reason (non-sufficient funds, account closure, etc.).

**K5 Graduation Fee:** \$50 - This amount will be billed on your April statement.

## Early Care and After Care (Hours not included in the Tuition Amount)

Early Care: 7:00 a.m. - 7:30 a.m. \$5 per day / \$20 per week

After Care\*: 2:30 p.m. - 6:00 p.m. \$15 per day / \$60 per week

- **Late Pick-Up Fees: \$15 in ten-minute increments** (\$15 for 6:01-6:10, \$30 for 6:11-6:20, etc.)
- All Early and After Care accounts must be kept current for a student to remain in the school.

Extended Care\* (if offered): \$180 per week

*\*Not offered for Grades 6-8*

**Tutoring:** \$30/hour

## Field Trip Transportation Fee

All academy classes taking a field trip will be assessed a fuel surcharge in addition to any admission fees.
